FOREST & ENVIORNMENT DEPARTMENT NOTIFICATION

The 20th December, 2019

No.25023/10F(TR)-34/2019-/F&E.— In exercise of the powers conferred by Section 45 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby make the following rules, to further amend the Orissa Timber and Other Forest Produce Transit Rules, 1980, namely-

1. (1) These rules may be called the Odisha Timber and Other Forest Produce Transit (Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Orissa Timber and Other Forest Produce Transit Rules, 1980 (herein after referred to as the said Rules), in rule 4, the following provisions shall be inserted namely:

"Provided further that the removal of timber in round form shall not be allowed to be transported outside the State unless it is converted in a valid licensed saw mill of the State."

3. In the said Rules, in rule 4, in the Schedule-II the species are as per Annexure-I

4. In the said Rules, in rule 5(1)(j), in Schedule-III the species are as per Annexure-II.

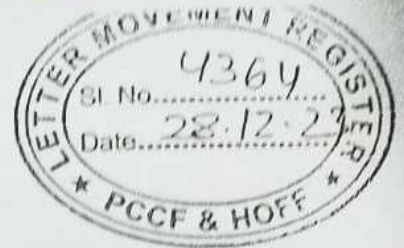

NOTIFICATION

The 27th December, 2023

No. 26504 FE&CC - In exercise of the powers conferred by Section 45 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby make the following rules, to further amend the Odisha Timber and Other Forest Produce Transit Rules, 1980, namely:-

- (i) These rules may be called the Odisha Timber & Other Forest Produce Transit (Amendment) Rules, 2023.
(ii) They shall come into force on the date of their publication in Odisha Gazette.
- In the Odisha Timber and Other Forest Produce Transit Rules, 1980, (here in after referred to as said rules), in rule-2, after clause (i), the following clauses shall be inserted, namely:-

" (j) Transit Permit in Form-I also includes a permit which is issued through ONLINE National Transit Pass System (NTPS) or in any Website notified by Government of India or Government of Odisha from time to time for transportation of Forest Produce throughout the Country including the State of Odisha".

(k) " No Objection Certificate means it is a certificate which is issued through ONLINE National Transit Pass System (NTPS) or in any website notified by Government of India or Government of Odisha from time to time for transportation of exempted species as listed in Schedule-III of these rules outside the State of Odisha". Note:-

- In the said rules in rule-4, after the third proviso the following proviso shall be inserted, namely:-
"Provided further that a Transit Pass or No Objection Certificate generated through National Transit Pass System (NTPS) portal of Government of India shall be valid within the State of Odisha".
- In the said rules, in Schedule-III, the [species] listed at Sl No.18 i.e. Palm Tree (*Borassus flabellifer*) shall be deleted.
- In the said rules, the rule-19 (Foreign Transit Permit) and rule-20 (Issue of fresh transit permit in lieu of Foreign Transit Permit) shall be deleted.
